

THE STATE OF TEXAS to the Sheriff or any Peace Officer of <u>Bexar</u> County, Texas or any Peace Officer of the State of Texas, GREETING:

WHEREAS, the Affiant whose name appears on the attached affidavit is a Peace Officer under the laws of Texas and did heretofore this day subscribe and swear to said Affidavit before me (which said Affidavit is here now made part hereof for all purposes), and whereas I find that the verified facts stated by Affiant in said Affidavit show that Affiant has probable cause for the belief expressed therein and establish existence of proper grounds for issuance of this Warrant; now, therefore, you are commanded to enter the suspected place described in said Affidavit and to seize same and to arrest and bring before me each suspected party named in said Affidavit.

Further, you are ORDERED; pursuant to the provisions of Article 18.10, Texas Code of Criminal Procedure, to retain custody of any property seized pursuant to this Warrant, until further order of this Court or any other court of appropriate jurisdiction shall otherwise direct the manner of safekeeping of said property. This Court grants you leave and authority to remove such seized property from this county, if and only if such removal is necessary for the safekeeping of such seized property by you, or if such removal is otherwise authorized by the provisions of Article 18.10, T.C.C.P. You are further ORDERED to give notice to this Court, as a part of the inventory to be fil-ed subsequent to the execution of this Warrant, and as required by Article 18.10, T.C.C.P., of the place where the property seized hereunder is kept, stored and held.

Affiant has been involved in investigations of individuals who derive substantial income from the illegal importation, manufacture, cultivation, distribution, and sale of illegal controlled substances. In addition, on numerous occasions, your Affiant has provided financial investigative expertise and assistance to various other agents of the Texas Department of Public Safety, and other various following enforcement units of county and city governments, in their investigations of individuals who traffic in illegal controlled substances. Your Affiant has also had extensive training and experience in the execution of narcotics search warrants, debriefing defendants, participant witnesses, informants, and other persons who have personal knowledge of the amassing, spending, converting, transporting, distributing, laundering and concealing of proceeds of narcotics trafficking. In addition, your Affiant has had extensive experience in the investigation of financial crimes committed by individuals who traffic in illegal controlled substances. Specifically, your Affiant have personally been involved in investigations involving organized, large scale contraband activities. Arrests and convictions of suspects have resulted from these investigations as well as the seizure of contraband.

The grounds for issuance of this warrant are derived from physical evidence, investigation and discussions between Narcotics Investigators.

Your Affiant states that the facts which establish probable cause necessary for the issuance of a search warrant for the above described -dwelling-are as-follows:

On 04-24-96, Affiant was present at the execution of a search warrant at the San Antonio International Airport, located at 10000 John Sanders, San Antonio, Texas. As a result of the execution of search warrant twenty (20) pounds of marijuana was seized.

Affiant further examined the package and the package was addressed to Jerry Chapman, at 8203 Meadow Fire, San Antonio, Texas. During further investigation Affiant learned through the Cole's Directory that 8203 Meadow Fire has been occupied by Fernando Varela Menache since 1991. Additionally, Affiant learned through the telephone directory that the above address maintains a telephone number as (210)681-2452 under Fernando Varela Menache since 1995.

The package was shipped from Express Shippers Center, located at 4700 San Dario, Laredo, Texas. The package was heavy taped, address was handwritten with no return address.

Affiant has personal knowledge that narcotics traffickers will frequently ship contraband via commercial carriers to themselves in another city to avoid detection while traveling from a well known source city along the border.

Furthermore, affiant has experience and personal knowledge from other narcotics agencies and law enforcement officers who have executed search

warrants at residences which invoices, receipts, bills of ladding, packaging, and documentation of previous shipments had seen seized.

On 04-25-96, Texas Department of Public Safety Narcotic Officers executed a search warrant at 8302 Meadow Fire, San Antonio, Texas. Subsequently, approximately twenty-two (22) pounds of Marijuana; one (1) Marijuana plant; three (3) plastics baggies containing Marijuana; several Marijuana seeds; assorted drug paraphernalia; one scale; miscellaneous papers; one Brycor :380 caliber handgun (Serial No. 118280); with one magazine and half box of ammunition; one 1994 Dodge pickup truck bearing Texas license plate LZ6-034; one 1991 Chevrolet pickup truck bearing Texas license plate 101-0ZN; and two recreational jet skies were seized. In addition, the San Antonio Police Department Asset Forfeiture Division seized several other items in regard to the execution of the search warrant. Arrested were Roque VELA, Jr., Jose Manuel TORRES, and Leopoldo RUIZ, IV - by San Antonio Police Department officers, Ben Esquivel and D. Williams, and were charged with Possession of Marijuana with bonds set at Fifteen Thousand Dollars (\$15,000) on VELA and TORRES and Five Thousand Dollars (\$5,000) bond set on RUIZ. All were remanded at the Bexar County jail in lieu of bond.

1. On 04-24-96, Texas Department of Public Safety Narcotics Sergeants James Bonewitz, Arnold Cano, Javier Cortinas, Lieutenant Ralph Sramek; San Antonio Police Department Officers. Steve Favorite, John Small, Jesse Hester, Sergeant Gaston and K-9 Droussard; and Texas DPS Criminal Intelligence Sergeant Hido Seanz were conducting a narcotics investigation at the San Antonio International Airport, United Parcel Services ("Next Day Air" - hereafter referred to as "UPS"), located at 10000 John Sanders, San Antonio, Texas.

2. At approximately 8:40 p.m., Sergeants Bonewitz, Cano, Cortinas and M. Garza observed one (1) brown cardboard box with several distinctive markings. The box had no return address, was originated from the Rio Grande Valley, shipping handwritten label to: Jerry CHAPMAN, 8203 Meadow Fire, San Antonio, Texas 78251.

3. At approximately 8:41 p.m., Sergeants Bonewitz, Cano, Cortinas and M. Garza removed the box from the conveyor belt for further inspection and investigation. Sgt. M. Garza also noticed that the box was originated from a private "mail drop facility" which contracts with UPS to collect parcels and ship the box or boxes from delivery "Next Day Air."

4. Additionally, the box was heavily taped around the seams. The box contained a tracking number as 07214613278. Exhibit #H was seized and described as tracking label.

5. At approximately 8:55 p.m., Sgt. M. Garza took the box into an empty building, and with the assistance of the San Antonio K-9 handler, Sgt. Gaston and K-9 dog "Droussard" obtained a positive alert on the box, which confirmed the officers and Sgt. M. Garza's suspicions.

6. At approximately 8:59 p.m., a search warrant for the brown cardboard box was obtained by Sgt. J. Patrick O'Burke and was signed by Judge David Peeples from the 224th District Court.

7. The brown cardboard box was opened and inside the box, Exhibit #1 was seized and is described as one white bundle wrapped with clear cellophane material, containing a green leafy substance suspected to be Marijuana, weighing approximately twenty-two pounds (22 lbs), and tracking number 07214613278.

8. On 04-25-96, at approximately 11:30 a.m., Sgt. M. Garza, acting as a UPS employee, delivered the package to 8302 Meadow Fire, San Antonio, Texas. A Hispanic male, approximately 5'11, brown short hair, wearing green shorts with no shirt and no shoes, answered the door. Sgt. Garza requested the Hispanic male to sign for the package, and the Hispanic male paused for a moment. Finally, the Hispanic male acting very slowly, carefully signed the delivery log utilizing the name "Jerry Chapman." During further investigation, the Hispanic male was identified as Roque VELA, Jr.

9. At approximately 11:40 a.m., Officer Sramek observed VELA exiting the dwelling carrying the brown box, and entering a white 1991 Chevrolet pickup, bearing Texas license plates 101-0ZN, driving away.

10. At approximately 11:43 a.m., San Antonio Police Officers Ben Esquivel, #1087 and D. Williams, #1138 stopped the pickup truck and arrested VELA. Inside the truck, the officers located the brown box; however, the contents of the box (Marijuana) were not located. Sgt. Dracoulis read VELA the Miranda warning inside the patrol vehicle.

11. At approximately 11:44 a.m., Officers Brain Petree, Al Cuellar, Jim Denman, Doug Phillips, Ralph Sramek, Kenny Dracoulis, Garland Gaston and K-9 dog "Droussard," and M. Garza executed a search warrant (see Attachment #1) at 8302 Meadow Fire, San Antonio, Texas.

12. At approximately 11:46 a.m., Leopoldo RUIZ IV, and Jose Manuel TORRES were arrested in connection with the investigation. Officer Phillips read RUIZ the Miranda warning and Sgt. Petree read the warning to TORRES.

13. At approximately 12 p.m., Sgts. Dracoulis, Petree and M. Garza found and seized Exhibit #7, described as a Chivas Regal whisky container, containing several Marijuana seeds, which was located on top of the dresser drawer.

14. At approximately 12:03 p.m., Sgts. Dracoulis and Petree found and seized Exhibit #G, described as a Brycor Arms, Model .380 automatic weapon, Serial No. 118280, with one magazine and half a box of ammunition inside the middle dresser drawer door.

15. At approximately 12:07 p.m., Officer Henry Cruz found and handed Exhibit #F to Sgt. M. Garza. Exhibit #F described as a black pocket pro scale located inside the master closet on top of the right-hand shelf.

16. At approximately 12:35 p.m., Sgt. M. Garza seized Exhibit #E described as TORRES' miscellaneous papers.

17. At approximately 12:40 p.m., Sgt. Gaston was dispatched to the location, along with the K-9 dog "Droussard" to assist in the execution of the search warrant.

18. At approximately 1:15 p.m., Sgt. M. Garza interviewed VELA, and VELA stated that everything inside the house was VELA's, and that TORRES and RUIZ were not aware of what was going on.

19. VELA advised Sgt. M. Garza that VELA had gone to Laredo and made arrangements to have the package (Exhibit #1) delivered to VELA. VELA then stated that VELA did not want to say much about the situation.

20. At approximately 1:45 p.m, Sgt. M. Garza interviewed TORRES in --reference to the items found inside the TORRES residence. TORRES advised Sgt. M. Garza that TORRES is in the process of buying the house, and that VELA was renting from TORRES and was not aware of what happened. TORRES advised Sgt. Garza that TORRES, VELA and RUIZ partied and did smoke some Marijuana, but that TORRES did not know about the large amount of Marijuana found inside the TORRES dwelling.

21. At approximately 2:35 p.m., Sgt. M. Garza interviewed RUIZ in reference to the matter. RUIZ advised Sgt. M. Garza that RUIZ was aware of what was going on, but RUIZ did not think that VELA was serious. RUIZ also admitted to smoking Marijuana, and that VELA had gone to Laredo to "make arrangements for something" and to visit VELA's family. In addition, RUIZ stated that the TORRES residence is a party house because TORRES had everything that a party requires.

22. Meanwhile, officers Petree, Phillips and M. Garza continued to search the premises. At approximately 2:55 p.m., officers found and seized Exhibits #3, #4, and #5, described as one clear plastic baggie containing a green leafy substance suspected to be Marijuana in the bottom drawer of a dresser in Carlo Kristian HEIN's bedroom. eighty-seven (87) grams; Exhibit #4 weighed approximately thirteen (13) grams; and Exhibit #5 weighed approximately fifteen (15) grams.

23. At approximately 3 p.m., Officer Phillips found Exhibit #B, described as one clear plastic bag containing several clear plastic baggies containing Marijuana residue found inside a white trash can.

24. At approximately 3:15 p.m., Sgt. M. Garza seized Exhibit #A, described as miscellaneous papers belonging to HINE.

25. At approximately 3:20 p.m., Sgt. M. Garza seized Exhibit #1, described as one white bundle wrapped in cellophane, containing a green leafy substance suspected to be Marijuana. Exhibit #1 was found on VELA's bed wrapped with several covers.

26. At approximately 3:25 p.m., Sgt. M. Garza seized Exhibit #C, described as one pipe utilized to smoke Marijuana containing Marijuana residue found on top of the dresser drawer inside VELA's bedroom.

- 27. At approximately-3-30-p.m., Sgt. Dracoulis found Exhibit #D, described as a black and white container containing several clear plastic baggies.

28. At approximately 3:40 p.m., another pipe utilized to smoke Marijuana containing Marijuana residue was located on top of the kitchen table.

29. At approximately 4:15 p.m., the K-9 handler and the K-9 dog arrived and conducted a thorough search.

30. At approximately 5 p.m., the K-9 alerted on Exhibit #2, described as one Marijuana plant outside TORRES' house.

31. At approximately 5:05 p.m., Officer Phillips found Exhibit #6, described as three hand-rolled cigarettes containing a green leafy substance suspected to be Marijuana. Along with Exhibit #6, a cigarette lighter and zigzag papers were found on top of the cabinets.

39. All evidence shall be retained by Sgt. M. Garza pending final disposition.


